Know all men by these presents that I William Thurston Sen<sup>r</sup>. of Greenville District in the State aforesaid for and in Consideration of two Thousand Dollars to me in hand paid by Waddy Thompson of the district and State aforesaid, Attorney at Law, I do ave granted bargained sold and released and by these presents do grant bargain sell sell and release unto the said Waddy Thompson all that plant<sup>t</sup>ation Tract or parcel of Land Containing Six hundred Acres be the same more or less, Situate lying and being in Greenville district on the waters of Reedy river beginning on a Post oak Corner on John Earles line; running thence N<sup>E</sup> 68<sup>W</sup> with said line 31 Ch<sup>s</sup> 50 links to a red oak on McElanathan line, thence S<sup>S</sup> 60<sup>W</sup> with s<sup>d</sup> line 45<sup>s</sup> 50 links a black Gum near the fork of a branch thence up the left hand fork of said branch with the meanders to the second fork. Thence up the middle fork of the s<sup>d</sup> branch to a Spanish oak at or near the head, thence S 51<sup>W</sup> 16 Ch<sup>s</sup> 70 links to a small Chestnut on John Robinsons line, thence with said line S 45<sup>E</sup> 25 Ch<sup>s</sup> 50 links to a pine knot by 3 post oaks, thence S 45<sup>W</sup> with said Robinsons line 48 Ch<sup>s</sup> 50 links to a Stake on the out line of said tract, thence S 45<sup>E</sup> with said old line 51 Ch<sup>s</sup> 50 links to a post oak corner, thence N 45<sup>E</sup> 24 Ch<sup>s</sup> 60 links to a Stake near a branch thence N 31<sup>E</sup> 36 Ch<sup>s</sup> 50 links to a Stake on Smiths line, thence S<sup>S</sup> 57<sup>O</sup> E 7 Ch<sup>s</sup> to a red oak corner on Earles line thence with Earles line to the begining, it being the same land I purchased of Joseph Willis — Together with all and singular the rights, members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all & singular the premises before mentioned unto the said Waddy Thompson his heirs and assigns for ever and I do hereby bind myself my heirs executors & administrators to warrant and forever defend all & singular the said premises unto the sd Waddy Thompson his heirs and assigns against myself & my heirs and against every other person or persons whom own lawfully claiming or to claim the same or any part thereof.
