I HAVE, granted bargained sold & released and by these presents Do Grant bargain sell & releas unto the said Nathaniel Jackson a plantation or tract of Land lying & being in Greenville District on the waters of Bear Creek of South Tyger river Beginning on a ash on a branch the begining River of said tract of land Running N. 10 W. 18. to a chestnut tree thence S. 77. till it runs to a corner that William D. Thomas made on a post oak where he run off this part of this land, thence a straight line along the back to the back line on the Mountain side thence to the Beginning Ash Containing by Estimation one hundred acres the same being part of a tract of land granted to Ruben Barrett by a patent bearing date the fourth day of ~~Decem~~ December in the year one thousand Seven hundred & Eighty six, And by the said Ruben Barrett sold & conveyed unto the said John Page Including the Improvement When the sd John Page now lives, adjoining Land surveyed for Ruben Barrett - - -

Togetther with all and singular the rights Members hereditaments & appurtenances to the said premises belonging or in any wise appertaining. To have and to hold all and singular the premises before mentioned unto the sd Nathaniel Jackson his heirs & assigns forever & I do hereby bind myself my heirs Executors & Administrators to Warrants and processes affinable & singular the premises unto the sd Nathaniel Jackson his heirs & assigns Against myself & my heirs & against every person whomsoever lawfully claiming or to claim the same or any Part thereof, In Witness whereof I have hereunto set my hand & affix'd my seal this Twenty seventh of November in the year of our Lord one thousand Eight hundred and four in the twenty ninth year of America's Independence, I did seal & subscribe in the presence of us, Ruben Barrett &
