 lars to me paid by Archib Holcombe of said District, I have gentle bargained  
 sold & Relied & by these presents Do Grant bargain sell & Release unto the said  
 Archib Holcombe a plantation or tract of land lying & being in Greenville dis-  
 trict on the head of Packs Creek of South Tyger river adjoining land Survey'd for  
 Reuben Barrett on one side, Beginning on a red oak corner running N. 70° E 35 to a post  
 Oak there next S. 20 E to a conditional corner on the branch thence down the S. branch  
 to a conditional corner then a straight line to one & more conditionly corner on a  
 Post Oak on the other line thence N. 20 W. to the Beginning corner on the Red Oak  
 the same being part of a tract of land granted to Shadrach Murray & by the said Murray  
 sold to County & unto the said Laben Loftis & by the said Laben Loftis this part sold & conveyed  
 unto the said Holcombe containing by estimation one hundred acres by the said  
 surveyor
