 post Oak on the other line thence N. 20 W. to the Beginning corner on the Red Oak  
 the same being part of a tract of Land granted to Hannah Murray & by the said Murray  
 sold & conveyed unto the said Laben Lofter & by the said Laben Lofter this part sold & conveyed  
 unto the s<sup>d</sup> Holcombe containing by Estimation one hundred Acres be the same
