South Carolina Greenville District, This Indenture made this seventeenth day of July in the year of our Lord one thousand Eight hundred & five Between Patrick McDowall & John Blair Merchants & Copartners of the City of Charleston in the State aforesaid, of the firm & Style of McDowall & Blair of the one part, and William Robertson of the District of Greenville and State aforesaid of the other part, Witnesseth that whereas the said William Robertson by his bond a obligation bearing even date with these Presents stands bound to the said McDowall & Blair and to their certain Attorney Executors administrators or Assigns in the penal sum of two Thousand & two hundred and thirteen Dollars & thirty two cents, Conditioned for the payment of the sum of one thousand one hundred & six dollars & sixty six cents payable according to the tenor and effect of the said Bond, Now this Indenture witnesseth that the said William Robertson for & in consideration of the said Debt a sum of, one Thousand one hundred & six dollars & sixty six cents, payable as aforesaid to the said McDowall & Blair for the better securing the payment thereof with Interest to the said McDowall & Blair according to the condition of the Bond aforesaid, and also for the consideration of the sum of five shillings sterling by them the said McDowall & Blair to the said W^m Robertson in hand paid at & before the sealing & delivery of these presents Doth grant bargain sell, alien, release & convey unto the said Patrick McDowall and John Blair merchants & Copartners as aforesaid and to their heirs & assigns forever - all that lot or parcel of land with the appurtenances whereon I now live situated in the Village of Greenville in the District and State aforesaid. Containing one half an acre and distinguished in the plan of the said Town by lot part of numbers thirty four & thirty five and also the following Negroes (to wit) Doctor Lucia & Dury - (Together)
