

Have Granted bargained sold and Released and by these presents do Grant bargain & sell unto the said Moses Kemp a certain tract or parcel of land lying in Greenville district on bushey Creek the waters of Enore River, containing three Hundred and twenty five acres, Whereas it begins on a pine corner, thence Running S: 60. E: 13. to a red oak corner from thence S: 30. W: 10. to a Red Oak corner. from thence N: 60. W: 13. to a red oak corner, from thence N: 30. E: 10. to the Beginning corner, and was granted to Cyprian Farrar the 15th day of October 1784. Witness his Excellency Benjamin Guiard Esquire Governor and commander in chief in and over the State Together with all and singular the rights ombrus hereditaments and appurtenances to the said Premises belonging or in any wise Incident or appertaining, To Have and To Hold all and singular the premises before mentioned unto the said Moses Kemp his heirs and assigns forever Against myself as attorney in fact for Cyprian Farrar, and against my heirs and his heirs, and against every person whomsoever Lawfully claiming, or to claim the same or any part thereof. Know all men by these presents that I James Nicoll of the State of South Carolina and Greenville County for and in consideration of the sum of Twenty Pounds Sterling, do bargain sell and confirm and by these presents do freely bargain sell & confirm unto Elijah Gorman of said County and State a tract or parcel of land containing Two hundred acres be the same more or less and lying and being in above County and State and on the north side of the Nolon mill Creek, and bounded as followeth (Viz) Beginning at a poplar corner Running thence N: 16. E: 70-00 to a red oak corner, thence South 54. E: to a conditional line made between Rich^d Forest & Solomon Forest thence along said line till it intersects the line laid off by John Nicoll thence along said line to the beginning, it being part of a tract of land granted to John Nicoll Together with all woods waters water courses orchards houses Gardens buildings & all the improvements thereunto belonging or in any wise appertaining, thence unto him the said James Nicoll To Have and To Hold said Bargained premises all and every part thereof to the said Elijah Gorman his heirs and assigns forever, and the said James Nicoll or him his heirs and assigns the said tract of land of Two hundred acres more or less. all & every part thereof for the said James Nicoll his Executors administrators heirs and assigns will warrant and forever defend the said tract of land unto Elijah Gorman his heirs Executors administrators and assigns, against all & every other person or persons whatsoever. In Witness whereof I have hereunto set my hand & Seal in the year of our Lord Eighteen hundred and Signed Sealed & Delivered in the Presence of us November 15th 1800
