Know all men by these presents that I John Dillingham of the County of Jackson and State of Tennessee in consideration of the sum of Sixteen hundred dollars to me in hand paid by Alexander McKinny of Greenville district State of South Carolina the receipt whereof I do hereby acknowledge, Have granted bargained sold released conveyed and confirmed and by these Presents do Grant bargain sell release convey and confirm unto the said Alexander McKinny his heirs or assigns a certain tract or parcel of land containing two hundred acres more or less Situate in Greenville district aforesaid on both sides of the north Fork of Saluda river and runs as follows (That is to say) Beginning on a white oak on the north side of said Fork thence South twenty degrees east forty four chains & twenty one links to a Hickory thence South seventy degrees West forty one chains to a white oak thence north twenty degrees West forty four chains and seventy two links to a black Jack thence to the Beginning the said tract of land was granted to Samuel Keibett the sixteenth day of July one thousand Seven hundred and Eighty four, Together with all and singular the here ditaments and appurtenances to the said Premises belonging or in any wise incident or appertaining. To have and To hold all & singular the Premises abovementioned unto the said Alexander McKinny his heirs and assigns forever. And I do for myself my heirs Executors and administrators warrant and forever defend all and singular the abovementioned Premises unto the said Alexander McKinny his heirs Executors administrators or assigns against myself my heirs Executors & administrators and against all and every other Person or Persons whomsoever Lawfully claiming or to claim the same or any part thereof. I witness whereof I have hereunto set my hand and affixed my seal the twenty seventh day of September one thousand Eight hundred and six.

This Indenture made this sixteenth day of September in the year of our Lord one thousand Eight hundred and six, Between Beverly Borroum of the district of Greenville and State of South Carolina, aforesaid of the one Part, and James Gooch of the same district & State of the other Part — Witnesseth that the same James Gooch for and in consideration of the sum of Seventy three dollars Have mortgaged unto the said Beverly Borroum his heirs or assigns the following Property one Grey mare two sows & hogs three Potts & one dutch oven one cow and calf & one bull two feather beds and furniture which said Property the said Gooch mortgaged unto the said Borroum in Virtue of having had and received of the said Borroum the said sum of seventy Three dollars the said Gooch having the Equity of redemption (that is to say, Paying & discharging) the said sum
