William Anderson sign seal and as his act and Deed deliver the within deed of  
Conveyance for the uses and purposes within mentioned, and that John Walker and  
Martin Adams together with this deponent were in the Presence of each others  
subscribing witnesses to the same - Sworn to and subscribed this 31<sup>st</sup> day of March  
1807 - John Young J.P. Recorded the 29<sup>th</sup> day of June 1807 Barksdale Terry

we Erasmus Ford & Levi Ford both of the State and District aforesaid, for and in Consideration  
of the sum of Two hundred and fifty Dollars to them in hand paid by Ellicajah Thomas  
Smith of the State and District aforesaid the receipt whereof is hereby acknowledged  
Have granted bargained and sold and Released, and by these Presents do bargain and  
sell and Release unto the said Ellicajah T. Smith now living & being in the State &  
District aforesaid, in the Cove of Green river, on both sides of Terry Creek, waters of  
Green River, containing three hundred and forty Eight acres of land be the sum  
more or less. Beginning on Eli. Fords poplar Corner, thence to John Cobins Conditional line  
thence with said line to Fords back line to a white oak, and thence with said line  
to William Cobbins Conditional line, and then with said line to Fords old line  
and thence with said old line to a black gum, thence to the conditional line, be between  
Erasmus Ford & Levi Ford the s<sup>o</sup> Conditional line beginning at the head of a  
branch that runs down between the house of Erasmus Ford and the apple orchard  
field, thence down said branch to Terry Creek, thence up the said creek, to the mouth  
of a branch that runs down by Stephen Longans old house then up the said branch  
to the Beginning corner, the same being granted to John Ford the nineteenth day of  
February in the year of lord 1795. by his Excellency Charles Pinckney Esq. Governor

the appurtenances premises unto the s<sup>o</sup> Ellicajah T. Smith from us and our heirs
