 Wafford Situate in Greenville district lying on Guilford creek the waters of Enoree
 river, Beginning at a pine on the east line of said tract running S. 70. W. 23. Ch. 50. links
 to Stake then S. 7. Chaining 25. links to Stake then N. 78. W. 18. Ch. 10 links to red oak then S.
 E. 19. Ch. 50. links to maple by a branch then up a small part of said branch to red
 oak 11 Chaining then N. 2. W. 25. Chaining to pine then N. 77. W. 12 Ch. 75. links to black oak
 then including all the southward part of said tract four four hundred acres of land
 less than be more or less, Together with all the premises and appurtenances thereto belon-
 -ing to the only proper use & behoof of him the said William Austin him his heirs
 Executors & adm^r or assigns forever, and he the said William Austin him his heirs
 Executors adm^r or assigns shall & may at all times have hold use occupy possess & enjoy
