 of Brushy creek waters of Enoree river, Beginning at a red oak 3+ sta for Joseph
 McAffee & George Ross thence on said line S. 68. 10. 9. to a stake 3+ thence N. 22. W. 2. ten
 Holly 3+ on the bank of a small branch thence up the meanders of said
 branch to a B. Gum 3+ thence S. 68. 16. 11. 50. to a hickory 3+ thence S. 40. E. 10. 50. to a
 Post oak 3+ on for Thomas Shalkeld thence on S. line N. 70. E. 29. to a stake 3+ thence S. 40
 E. 2. 50. to a red oak 3+ thence S. 75. E. 3. 50. to a red oak 3+ thence N. 31. E. 11. to a Sowerwood 3+
 on the bank of SA Creek, then up the meanders of said creek to the Beginning, which
