and by these presents do bargain and sell and in plain and open market deliver  
to the said Joshua Benson the following property one black stud horse about thirteen hand  
half high seven years old with a star in his face one brown Cow with sawed horns  
feather beds and furniture two bedsteads four earthen dishes & eight plates two tea p[ot]  
three butter pots Case knives and forks one Office mill candle molds six Spoo[n]  
six barrels of corn one large pot one oven one baker one tea kettle one Shaving  
Skillet one trunk one chest one cotton wheel and cards one plow & hoe one saddle third  
one boot Legs Sole leather one kit of shoe makers tools one soap spoon one wash tub  
one pale one piggie one soap box one looking glass one hatchet one axe one plow one pair  
hames and Chains To Have and To Hold all the aforesaid property and the increase  
the S<sup>r</sup> Stock unto the said Joshua Benson Executors administrators and assigns forever prov  
always nevertheless that if the S<sup>r</sup> John Mason his heirs Executors administrators shall and  
will and truly pay or cause to be paid unto the said Joshua Benson his certain at  
his heirs Executors administrators or assigns the full & just sum of thirty two dollars &

the bill bond or obligation aforesd and of these presents then this deed of bargain &

and be utterly void and of none effect anything herein before contained to the con  
trary in any wise notwithstanding and it is hereby declared by & between the S<sup>r</sup> parties  
and the said John Mason for himself his Executors and administrators do covenant prom  
ised and agreed with the said Joshua Benson his Executors & administrators and assigns  
by these presents that if default shall happen to be made of or in payment of this sum  
thirty two Dollars and twenty five Cents with the interest thereon as aforesaid according  
the true intent and meaning of the said bond or obligation and these presents that  
and in such case it shall & may be lawfull to and for the said Joshua Benson his exec  
attorney his heirs Executors administrators or assigns or against from time to time and at  
times hereafter peaceably & quietly to enter into any or all the lands mentioned or tenement
