

In Witness whereof I have hereunto set my hand & seal this 22<sup>nd</sup> day of August in the year of our Lord one 1808. & in the thirty third year of the Independancy of the United States of America —

I, Carolina Greenville District, Personally came Andrew M. Crary one of the subscribing witnesses to the within deed and made oath that he saw Arch<sup>d</sup>. Lester sign and as his real act and deed deliver the within deed for the uses and purposes therein mentioned, also that Banister Stone together with himself subscribed their names as witnesses to the said execution of the same, Sworn to & subscribed before me this 25<sup>th</sup> November 1808.

State of South Carolina, Know all men by these presents that I George Salmon of Greenville District and State aforesaid, in consideration of the love I have & bear unto my Daughter Harriet Ford as well as in consideration of the sum of one Dollar to me in hand paid by the said Harriet Ford the receipt whereof I do hereby acknowledge, Have granted bargain sold conveyed and set over and by these presents Do grant bargain sell convey set over unto the said Harriet Ford her heirs and assigns all that plantation tract of Parcel of land containing by estimation three hundred and Seventy acres more or less situate in Greenville District of aforesaid on the branches of Chickarod River waters of Saluda River and runs as follows, that is to say, Beginning on a white oak the beginning of my old tract thence North Eighty seven degrees West to a white oak Jacksons corner thence with said Jacksons line to a stake on Thomas McCannells line thence South sixty five Degrees East to a poplar McCannells corner thence South twenty five west a branch thence said branch to a dogwood at or near a shoal thence with a conditional line between Josiah Cooksey and the land hereby conveyed to Frenchs line thence said line to a pine thence North twenty Degrees East to the Chain
