State of South Carolina Greenville District; This Indenture made the twenty first day of September one thousand Eight hundred and ten, between Aaron Swafford and Moses Swafford both of the state and district aforesaid, Witnesseth that the said Aaron Swafford for and in consideration of the sum of Three hundred and Eighty dollars to him in hand paid the receipt whereof is hereby acknowledged, the said Aaron Swafford, hath bargained sold and released unto the said Moses Swafford fifty acres of land more or less situated on the south side of Tyger river, in the district aforesaid bounding on the widow Lankford land with reference to a deed from William Few to Thomas Howard also twenty acres more or less adjoining the above mentioned land Beginning at Peter Howard's corner on a post oak on said Howard's line to a stake thence on a conditional line to a stake on the widow Lankford's line thence to the beginning with reference to a deed from Jacob Swafford to Thomas Howard, another tract or parcel of land containing fifty acres more or less adjoining the above mentioned land being part of a tract granted Nicholas Jasper Beginning at a post oak corner thence to a black oak on the line thence to a hickory on the river thence as the river runs to the line thence to the beginning reference to a deed from Peter Howard to Thomas Howard in all one hundred and twenty acres more or less. by these presents the said Aaron Swafford doth bind himself his heirs Executors & Administrators to warrant and forever defend the above one hundred and twenty acres of land more or less with all its rights & appurtenances unto & for the said Moses Swafford his heirs & assigns forever, against all claims whatsoever or in any wise lawfully claiming said Land.
