The State of South Carolina Know all men by these presents that I James  
Lewis do for and in consideration of Twenty pounds Sterling to me in hand paid by  
Isaac Towers senior and both of Greenville County and State aforesaid I the said  
James Lewis do grant bargain sell and Release unto the said Isaac Towers senior  
all that tract or parcel of land containing one hundred and eighteen acres  
be the same more or less it being a part of a tract of Two hundred and fifty  
Originally grant to Joshua Saunders by patent bearing date the twenty first day  
of January in the year of our Lord one thousand seven hundred and Eighty  
five, situate in Greenville County and State aforesaid on the south side of  
Eocene River, on both sides of Peters creek Waters of Eocene River the land to be conveyed  
Begins at a Post Oak 3+ old marked for said tract on the N. side of Peters creek Waters of Eocene  
River and runs N. 60 W. 25 chains on the original line to a Stake new made, then through  
said tract S. 30 W. 14.50 to a Stake corner new, then S. 60 E. 6 ch. to a poplar 3+ new. Then  
S. 30 W. 10.50 to a Stake 3+ new on the original line, then on said line S. 60 E. 19 ch. to a  
Hickory 3+ old. then on the old line N. 30 E. 50 chains to the beginning Post Oak corner  
which includes the full land to be conveyed be the same more or less. Together with all &  
singular the right, members, hereditaments and appurtenances to the said premises belonging  
or in any wise incident or appertaining. To Have & To Hold all and singular the premises  
before mentioned unto the said Isaac Towers senior his heirs and assigns forever, and I  
do hereby bind myself my heirs executors and administrators to warrant and forever  
defend all and singular the said premises unto the said Isaac Towers senior his heirs  
and assigns against myself and my heirs and against every person whomsoever lawfully  
claiming or to claim the same or any part thereof. Witness my hand and seal this  
28<sup>th</sup> day of April in the year of our Lord one thousand seven hundred & ninety  
Eight, and 22<sup>nd</sup> year of the independence of the United States of America -
