 aforesaid in the Village at Greenville Courthouse (called Pleasantburg) known and
 distinguished in the Plan or Chart of said Village by the number forty six (46) & being
 the same next Lot above the Corner Lot whereon Atstons Blacksmith's Shop stands —
 Beginning on a Stake Corner, near a Sycamore, running thence North twenty four & half
 degrees West One hundred and seventy six and a fourth feet to a Stake, then North
 fifteen and an half degrees East one hundred feet to a Stake, then South twenty
 four & half degrees East one hundred and seventy six and a fourth feet to a Stake,
 then South 15 1/2 degrees West One hundred feet to the beginning Containing one
 half acre, being the same Lot which I purchased of Lemuel J. Atston as may appear
 by Deed bearing date the first day of October 1807. and Recorded in the Clerk's office
 of said district in book H. page 16 the 28th of October 1807. Together with all & singular
 the rights members hereditaments and appurtenances whatsoever to the said premises
 belonging or in any wise incident or ^{held deemed or taken to be thence} appurtenant, To have & To hold all and singular
 the premises before mentioned unto the said George W. Earle his heirs & assigns forever
 And I do hereby bind myself my heirs Executors & Administrators to warrant & forever
 defend all and singular the said premises unto the said George W. Earle his
 heirs and assigns against myself and my heirs and against all and every other
 person or persons whomsoever Lawfully claiming or to claim the same or any part
 thereof, Witness my hand and seal this nineteenth day of March in the year
 of our Lord one thousand Eight hundred and twelve, and in the thirty sixth year
 of the Independence of the United States of America, Signed sealed & Delivered
