

Executors administrators and assigns against me the said Catharine Easley my Executors and administrators and all and every other person and persons whomsoever, shall & will warrant and forever defend by these presents of all and singular which goods and Chattels personal Estate and other the premises I the said Catharine Easley have put the said Thornton Benson in full possession by delivering to him one young sorrel horse at the time of the sealing and delivery of these presents in the name of the whole premises hereby given and granted, but be it always remembered that I do by these presents reserve to myself during my natural life the disposal of the profits benefit and proceeds arising from the work and labour of the slaves above mentioned together with the use and full enjoyment of the other property above mentioned (the horse now delivered excepted) and after my decease the above deed to be in full force and virtue as above mentioned. In Witness whereof I the said Catharine Easley have hereunto set my hand and affixed my seal the sixteenth day of November, one thousand Eight hundred and ten, the words 'my' in the first line in the proviso intended before signed, signed sealed & delivered in the presence of

South Carolina Greenville District, True Benson personally appeared before me the undersigned Justice and being duly sworn on his oath sageth that he saw Catharine Easley sign and seal the within deed of gift or instrument of writing and acknowledge it to be her act and deed and deliver it for the purposes therein mentioned and that Geo. The State of South Carolina Know all men by these presents that I Patrick Moore of Greenville district in the State aforesaid for and in consideration of the sum of five hundred Dollars to me in hand paid by Elisha Green of the district and State aforesaid Have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Elisha Green all that tract or parcel of Land containing two hundred acres more or less situate lying and being in Greenville district north of the beaverdam creek a branch of Enoree River Beginning on a switchwood tree on the S. Beaverdam creek joining Enoch Benson's land running thence N. 13 W. 5. 50 to a Post oak 34 thence N. 27 W. 15. 30 to a post oak 37 thence S. 03 W. 14. 30 to a red oak 37 thence N. 10 Chain 66 links to a post oak 37 thence N. 58 W. 19 to a red oak 37 thence due north 8. 20 to a pine thence due north 31. 50 to a stake or black jack joining Benjamin Whorton's line now claimed by Laborn P. Pool thence S. 19 E. 54. 50 to two maples on the said beaverdam creek thence down running down the middle of said creek or the meander of said creek to the Beginning; Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining
