Kinney a certain tract or parcel of land being fifty acres, being the same more or less, lying and being in the State of South Carolina and Greenville District, lying on the east end of the Walnut mountain beginning on a Chesnut thence to a Stake, thence to a Poplar thence to Chesnut, thence to Chesnut thence to Conditional Corner, between Philip Guise and the said William Daniel, thence to a Conditional Corner on a Walnut, between the said William Daniel and Jacob Cain from thence to the beginning Corner - I the said William Daniel do warrant & defend the write & title of the above Premises with all woods, waters & water courses profits, services & leagues unto the said Alex<sup>r</sup> M. Kinney his heirs and assigns - In Witness I have hereunto set my hand and seal - this 26<sup>th</sup> of July 1812. William Daniel

Kinney a certain tract or parcel of land containing one hundred and fifty acres Situate in Greenville District on the branches of Fall creek, waters of the north fork of Saluda river, including the Walnut Mountain, beginning on a Chesnut on a conditional line between said Guise & said M. Kinney's land from thence to a Chesnut Station, thence to a Sowerwood corner, thence to a Chesnut Corner, thence to a Chesnut Corner, from thence to Robersons fork of fall creek at the Conditional line between said Guise and Jacob Cain running down the creek to the original ~~plat~~ line, thence to a Stake, thence to a Stake, and from thence to the beginning Corner, being by estimation one hundred and fifty acres, more or less, Together with all and singular the rights, members hereunto and appertaining, to the said premises belonging or in any wise incident or appertaining, To have and to hold all & singular the premises
