Know all men by these Presents that I Josiah Thompson of Greenville District in the State aforesaid, Planter, for and in consideration of five hundred dollars to me in hand paid by Jeremiah Cleveland of the district and State aforesaid, Merchant. Have granted, bargained, sold and released, and by these Presents do grant bargain sell and release unto the said Jeremiah Cleveland his heirs and assigns, All that Piece or parcel of Land containing sixty eight acres, Situate lying and being in the district and State aforesaid on the Golden Grove creek, waters of Saluda river, being part of a tract of land originally granted to Nathaniel Pendleton Esq^r by grant bearing date the 16th of July 1784 and by him conveyed to Waddy Thompson Esq^r, and by him to me. The part now to be conveyed Begins on a Sweet gum on the bank of the creek, where the lower original line crosses it, thence along the original line N^o twenty five degrees East Sixty five chains to a Red Oak corner, made to divide this piece from a piece sold Tarrant, thence South seventy four degrees West, twenty four chains and fifty links, to a Gum on the bank of the creek thence down the meander of the creek to the beginning, Bounded on the West by land heretofore sold said Cleveland, on the North by Carter Tarrant's land, and on the S^o C. by land belonging to the heirs of Larkin Tarrant, and hath such shape form and marks as are represented by a plat here to annexed. Together with all and singular the rights members & appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Jeremiah Cleveland his heirs and assigns forever. And I do hereby bind myself my heirs or executors and administrators to warrant and forever defend all and singular the premises before mentioned unto the said Jeremiah Cleveland his heirs and assigns against myself and my heirs and against every person or persons whomsoever lawfully claiming a to claim the same or any part thereof.
