This Indenture made this sixth day of March one thousand eight hundred & thirteen, between Haden Bruce of Greenville District & State of South Carolina of the one part & William King of the State & Districts of the other part, witnesseth that for and in consideration of eighteen Dollars in hand paid by W^m King the receipt whereof is hereby acknowledged by s^r Haden Bruce hath bargained & sold & by these presents doth grant unto W^m King his heirs & assigns forever a certain tract or parcel of Land lying in Greenville District of S^r Carolina containing twelve acres more or less, joining s^r W^m King's Land beginning on a post oak & running S. 26^W to the next & thence N. 63^W (through an old field that once belonged to John Turner) to a red oak thereon to a red oak on the bank of Shad Creek thence down the meander of s^r Creek to the conditional line between Joel Bruce & s^r W^m King thence on s^r Conditional line to the beginning to have & to hold s^r land with all the rights & privileges thereunto belonging to him the s^r W^m King his heirs and assigns, Executors, & administrators forever to the s^r Haden Bruce for himself his heirs Executors &c. do hereby promise and agree to & with s^r W^m King his heirs &c. shall & may for ever peaceably & quietly have hold & occupy aforesaid lands without the least molestation of any person or persons whatever & the said Haden Bruce doth oblige himself his heirs Executors administrators & assigns to warrant & for ever defend s^r lands & premises to him the s^r W^m King his heirs & assigns against the claims of all persons.
