and by these presents do grant, bargain, sell and release unto the said George Hopkins  
a parcel of Land, containing one Hundred and Forty Acres more or less it being a part  
a grant originally granted to John Buchanan Laying in the District aforesaid  
on the waters of Keady River Beginning on a black oak and running N. 14 Ch. 30 Lk.  
to a Black Oak, thence N. 34 W. 47 Ch. 40 Ls. to a Hickory, thence N. 10 Ch. to a  
Chesnut, thence S. 45 Ch. to a Hickory bush, thence N. 84 E. 12 Ch. 70 links
