Bed Cloaths or furniture and Spun Cotton in whose hands Custody or posses-  
-ion soever they be or wheresover. The same or any part of them, or any part of  
them can or may now <sup>or hereafter</sup> be found remaining or being To have and to hold  
all and singular the said money, Cash Notes, debts Cloathing Bed cloaths  
and Spun Cotton above mentioned unto the said Eliza Salmon Davis her  
heirs and assigns forever — In witness whereof I have hereunto set my hand  
and affixed my Seal the Thirteenth day of August in the Year of our  
Lord One Thousand Eight Hundred & Thirteen — I do authorise and  
appoint William Ford of Greenville District to collect the money owing  
to me and put it to Interest until my Daughter arrives at the age of  
Eighteen Years or marries and Elizabeth Salmon to collect the Cloathing  
and give it to my said Daughter <sup>at her discretion</sup>. Signed seal. and acknow-
