District and the State aforesaid have Granted bargain sold & released  
and by these presents I do Grant bargain sell & release unto the said  
William Edwards all that Tract or parcel of Land lying & being in  
Greenville District & State aforesaid on the waters of Burnses Creek and the  
branches of Trouhawk Creek, beginning on a Black Jack corner running  
N. 30. E. 104 chains to stake corner, thence S. 78. W. 59 ch. to a small chestnut  
near an old corner, thence S. 70 W. 36 ch. to a post oak Sapling, thence a  
straight line to John Wilsons Stake corner, thence along Wilsons line to a  
Black Jack corner at the beginning containing Four hundred and Sixty  
acres be the same more or less To go therewith all & singular the rights mem-  
bers hereditaments & appurtenances to the said premises belonging  
or in any wise incident or appertaining to have & to hold all & singular  
the premises before mentioned unto the said William Edwards his heirs  
and assigns Forever, and I do hereby bind myself my heirs Executors and  
administrators to warrant and forever defend all and singular the said  
premises unto the s<sup>d</sup> William Edwards his heirs and assigns against
