South Carolina, Know all men by these Presents that I Henry Prince of Greenville District, and State aforesaid, in consideration of the Love and good will which I have and bear to and for my sons Thomas Prince & Henry Prince Jun<sup>r</sup>. of the District aforesaid, as well as in consideration of the sum of two Dollars to me in hand paid by the said Thomas Prince and Henry Prince Jun<sup>r</sup>. the receipt whereof I do hereby acknowledge, Have granted bargained sold Released Conveyed and Confirmed, and by these presents do grant bargain sell Release Convey and Confirm unto Thomas Prince and Henry Prince Jun<sup>r</sup>. their heirs and assigns all that Plantation tract or parcel of land whereon I now live, containing four hundred and ninety eight acres, Situate in Greenville District aforesaid on both sides of South Tegu river, granted to myself by Grant bearing date the Sixteenth day of July one thousand seven hundred and Eighty four, and runs as follows (that is to say, Beginning on a Hickory on the south West side of Tegu river, thence South Sixty four degrees East thirty chains to a red oak, thence South thirty degrees East forty five chains to a black oak, thence North Sixty degrees East, sixty five chains to a Red Oak, thence North thirty degrees West, seventy five chains, to a
