day of October in the year of our Lord one thousand eight hundred and fourteen
between John Wood, Sheriff of Greenville district in the State aforesaid of the one
part, and John French, of the other part. Whereas by virtue of a Writ of
Fier Faitas which issued from the Court of Common Pleas at Greenville Courthouse
at the suit of Miles Innings against George French directed to all & singu-
lar, the Sheriff of the said State, greeting. which execution was duly entered
in the Sheriff's Office of S^t district, the said John Wood did enter upon & seize
under the said execution a certain tract or parcel of land, herein after
described, and, after, and after notice of the intended sale of said Land
did on the sixth day of June in the year of our Lord one thousand eight
hundred and fourteen, openly publicly & fairly according to the custom
of vendors expose (subject nevertheless to all legal encumbrances
that may be against the said land or any part thereof) the same to
Sale to the highest bidder at Greenville Courthouse in the district
aforesaid — said land being so exposed was struck off to said John
French for the sum of four dollars and twenty five cents, he being
the highest and last bidder for the same. Now this indenture
Witnesseth that the said John Wood as Sheriff of Greenville District
aforesaid in consideration of the sum of four dollars and twenty five cents to
him in hand paid by the said John French the receipt whereof is
