The State of South Carolina Greenville district. We the subscribers Heirs and Representatives of James Harrison deceased, having divided the negroes belonging to the estate, & disposed of some other articles, and having removed the incumbrance from the real Estate, all being done in a just and amicable manner; do for the furtherance of a final settlement, as it regards the property undisposed of, made the following arrangement. 1st All the lands belonging to the Estate shall be divided, and laid off into Tracts of such sizes, and dimensions, as it is supposed, would be the most Saleable and would bring the most money, regard being had to the particular, and relative situation of the land. 2nd That after the above article is complied with, timely notice shall be given, and the whole of the real Estate shall be sold to the highest bidder, on a Credit of one, two & three years, the payment to be made by equal installments, and title not to be made until the actual payment of the money, the purchaser shall give his bond and approved security, and pay interest after the first installment.

At the above sale the heirs must all attend, in order to execute a bond for titles, as no one person would be willing alone to enter into the bond, this however shall not prevent the sale if any one will do so, or the land can be sold without it.

3rd The land shall be laid off by John H. Harrison, he having the best knowledge thereof, the sale shall commence on the second Monday in October next, and James Harrison and Thomas Harrison shall be associated with John H. Harrison in laying off the land. - 4th Jane Wright shall have the use of part of the Plantation, until the sale, and also the House - to wit, all the land on the other side of the Creek above Cooks branch and all the land on this side of the Creek that she may think proper. - 5th John H. Harrison shall have until that time the use of the balance of this and Simpkins plantations - all that he cannot tend himself he shall be at liberty to rent out for the benefit of of the heirs. - 6th all the balance of the personal property, except the sows and pigs & young hogs, shall be set up & sold at Public auction on a credit of twelve months, purchaser giving bond and Security. 7th The Notification of the Sale and time of Selling shall be made by John H. Harrison, and the Notes shall be made payable to him, who shall receive the same for the heirs, and settle the books accounts of Isaac & Thomas
