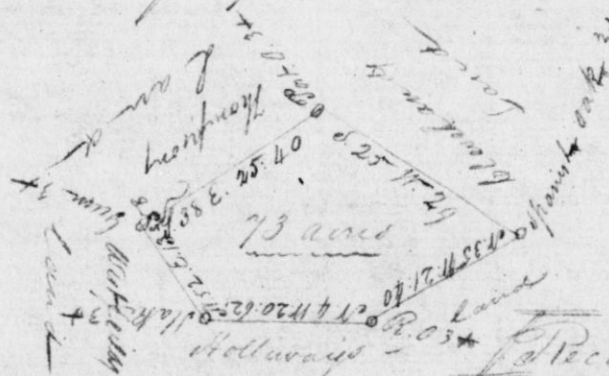

Gowen of the State and duties aforesaid in consideration of the sum of sixty dollars paid by William Holcombe Senior of the district aforesaid have granted bargained sold and released and by these presents do grant bargain sell and Release unto the said William Holcombe Senr. all that tract or parcel of land lying and being in the district aforesaid on the head waters of Middle Cypre River Beginning on a chestnut thimble E 27.50 to a poplar thimble S 20 W 25 to a chestnut thimble S 54 E 8 to a poplar thimble to the beginning corner it being part of a tract of land granted to John Gowen containing forty five acres to the same more or less Together with all and singular the Rights members hereditaments and appurtenances to the said bargained premises belonging or in any wise appertaining, To Have & to Hold all and singular the premises before mentioned unto the said William Holcombe his heirs and assigns forever And I do hereby bind myself my heirs Executors & administrators and assigns forever to warrant and defend all and singular the said premises unto the said William Holcombe Senior his heirs and assigns against myself & my heirs and against every other person whomsoever lawfully claiming or to claim the same of any part thereof - In Witness whereof I have hereunto set my hand and seal this 17th day of November in the year one thousand Eight hundred and fifteen.
