do grant bargain and sell unto the said Gowin Harris all that tract
or parcel of land, it being part of a tract of land laid out to Robert Sego, con-
taining five acres, more or less, Beginning on a Stake in the road on
Norman's line running S 10 W. 5 chains to a post Oak, thence N. 80 W. 11 chains 25
links to a Stake by a red Oak, thence N. 10 E 5 chains to a Hickory on the edge
of the road, thence with the road to the beginning, together with all singular the
rights members hereditaments and appurtenances, to the said premises belonging
or in any wise incident or appertaining; to have and to hold all singular
the premises before mentioned unto the said Gowin Harris his heirs & assigns
forever, and I do hereby bind myself my heirs executors & administrators
to warrant and for ever defend all and singular the said premises unto the
said Gowin Harris his heirs and assigns against myself and every other person
whomsoever lawfully claiming or to claim the same or any part thereof -
