by these presents that Jacob Black of Greenville District and  
State of Carolina for and in consideration of the sum of Two  
Hundred Dollars to me in hand paid by Jacob Black Jun<sup>r</sup>  
have bargained sold and by these presents doth bargain  
sell and release to the S<sup>r</sup> Jacob Black a plantation or  
Tract of Land containing one Hundred and Eighty seven  
Acres more or less beginning as follows on a black oak  
corner thence N. 40 E. 48. 1/4. to a stake corner thence N. 86  
W. 01 E. to a post oak corner thence S. 40 W. 42. 50 to a  
Maple stump corner thence S. 50 E. 50-85 to the beginning  
including one Hundred and Eighty seven acres of land more  
or less together with all and singular the Rights and all that  
appertains to the S<sup>d</sup> Land and Premises before mentioned  
to the S<sup>r</sup> Jacob Black Jun<sup>r</sup> his heirs and assigns for ever  
and I do hereby bind my self my heirs and assigns to  
warrant and for ever defend all and singular the S<sup>d</sup>  
premises to the S<sup>r</sup> Jacob Black Jun<sup>r</sup> against myself  
my heirs and assigns and against all other persons

claiming the same or any part thereof whereunto I the  
S<sup>r</sup> Jacob Black do hereunto set my hand this 8 day of  
January Eighteen Hundred and Seven in presence of  
us
