


203 State of South Carolina Greenville District Know all men by these presents that I Peter Howard of the State & District aforesaid for an inconsideration of the sum of two Hundred & fifty Dollars to me in hand paid by Francis Adams of the State & District aforesaid have granted bargained sold & released & by these presents do grant bargain sell & release unto the said Francis Adams a plantation or tract of Land lying & being in the State & District on the Waters of middle Tyger river Beginning on a red oak corner on Runnels Dells & Francis Adams Lines thence along the said Adams line to one more red oak corner thence a straight line to a post oak corner on Wm. Chastains line thence along the S<sup>r</sup>. Chastains line John Dell line Runnels Dells line to the Beginning corner containing by Estimation one Hundred & thirty Acre or less the same being a part of a tract of Land Granted to John Gowen together with all and singular the rights members Accidents & Appertinances to the said premises or in any wise appertaining to have & to hold all & singular the premises before mentioned unto the Francis Adams his heirs & assigns for ever & I do here by Bind my self my heirs Executors & Administrators to warrant & forever defend all & singular the premises unto the said Francis Adams his heirs & assigns against my self my heirs & against all and Every other person or persons lawfully claiming or to claim the same or any part thereof in Witness whereof I the S<sup>r</sup>. Peter Howard have here unto set my hand & affixed my seal this February the Twenty third day one Thousand Eight hundred & Eighteen and in the forty first year of America independance Signed Sealed & Delivered in the presents of us the Witnesses
