

South Carolina Pickens District Know all men by these presents that I William Thurston of the District & State aforesaid for & in consideration of the sum of Two Hundred Dollars to me paid by Thomas Prince of the District of Greenville & State aforesaid have Granted Bargained sold & Released & by these presents do bargain sell & release unto the said Thomas Prince a certain tract or parcel of Land containing Two Hundred & Eight Acres more or less lying & being in the District of Greenville & State aforesaid lying on the Waters of Hoopers Creek Branch of Saluda Beginning on a road Oak on Cabins Harves line running thence North 78 West 60 Chains to a Hickory thence North Twenty two West 19 Chains to small Road Oak thence North 42 East 22 Chains to a Road Oak on Isaac Bradley line thence North 58 East 32 Chains to a Road Oak thence North 41 East 12 Chains to a Road Oak near the Mile Post thence South 13 East 7 Chains to a Road Oak thence South 10 East 19 to a pine Stump thence South 80 East 16 Chains to a Road Oak thence South 9 West 20 Chains to the beginning Road Oak on Harves line together with all & singular the rights members hereditaments and Appurtenances unto the said land belonging or in anywise incident or appertaining to the same to have & to hold all & singular the premises
