Kelly of Greenville District & State aforesaid for & in consideration of the sum of Three Hundred Dollars to me in hand paid by Samuel Hecke of the District & State aforesaid have Granted bargained sold & released unto the said Samuel Hecke a plantation or tract of land lying & being situate in the District & State aforesaid on a small Branch Water of Lady River it being a part of a tract originally Granted to John Lafferty on the sixth day of October in the year one Thousand Seven Hundred & Eighty Eight & conveyed through Different hands down to the said Kelly the said to be Conveyed begins on a stake in the big Road & runs due south 17 chains to a pine 3x 8 1/2 to Red O. 3x 5 2 1/2 & 1/2 is a Stake 3x 1 1/2 E. 16 ch. to a P. O. 3x N 32 E 33 ch. to a stake bounded by Blacks land N. 44 E. 15 ch. to a Maple 3x on branch then down the P branch 18 ch. to a Stake 3x N. 16 E. 13.50 to a pine stump on the big Road then with the said road to the beginning stake bounded by Joseph Kellys land bounding on Hundred & thirty two acres more or less together with all & singular the rights & appurtenances & appertaining to the premises belonging or in any wise appertaining to have & to hold all & singular the premises before mentioned unto the said Sam^l Hecke his heirs & assigns & to the lawful heirs & assigns my self my heirs Executors & Administrators to Warrant & forever defend all & singular the premises before mentioned unto the said Samuel Hecke his heirs & assigns for ever against my self my heirs & against Every other person or persons Whomsoever lawfully claiming or to claim the same or any part thereof In Witness Whereof I do hereunto set my hand & Seal this Thirtieth day of July one Thousand Eight hundred & twenty two signed sealed & Delivered in presence of us
