five Acres be the same more or less, & Joining the Land Lewis of
Wm Thackston Henry Stokes John Thackston & Edward Prince
Together with all the singular the rights Members Tenements &
Appurtenances with all the appurtenances thereunto belonging or
in any wise appertaining or incident unto the said John Estes his heirs
& Assigns For Ever, to have & to hold Use Occupy possess & Enjoy
the same with every part & parcel thereof to him the said John
Estes his heirs Exors Adms & Assigns for Ever & I do hereby
for my self my heirs Exors & Adms warrant & forever defend
the Right & Title free from myself or the claim of my heirs Exors
adms or Assigns & from the claim of every other person or person
whatsoever Lawfully claiming or to claim the same or any part thereof.
