

Rocky creek on a line dividing between said Ashmore & land 280  
also sold to Benjamin Jones & runs on said line N. 21. West 35 Chains &  
fifty links to a pine corner on John Brashers land then on said  
Brasher's line running nearly N. 12 W. 22 Chains to a red oak corner  
on Thomas Long's line thence on said Long's line running N. 60 E. 15 Chains  
& fifty links to a stake corner on William Richardson's line thence on said  
Richardson's line S. 31 E. 45 Chains to said Rocky Creek thence down the  
meanders of said Creek to the beginning corner including the plantation  
whereon said William Ashmore now lives & supposed to include one hundred  
& forty acres of land to be the same more or less. Together with  
all & singular the appertinances thereunto belonging to the said John  
Ashmore for himself his heirs Executors & Administrators doth covenant  
& Agree to & with said William Ashmore his heirs Executors Administrators  
& assigns that he the said John Ashmore will forever warrant & defend the  
above described plantation or tract of land with all its appertinances  
Hereditaments commodities Rents issues privileges & advantages whatsoever  
thereunto belonging or in any wise appertaining thereunto from himself  
his heirs Executors Administrators & assigns or any other person or persons whatso-  
ever laying any just or lawful Right Title claim or interest thereunto  
or any part thereof but to the only proper use & behoof of him the said  
William Ashmore his heirs Executors Administrators & assigns forever. In witness
