four hundred Dollars to me paid by Robert Deane of the State & district  
afo. have granted bargained Sold & Released & by these presents do grant  
bargain Sell & release unto the Said Robert Deane a plantation or tract of  
land lying in the State & district afo. on the South Side of the Southfork  
of Rabun's Creek water of Neely River it being part of a tract of land  
originally granted to Cornelius M. Mahan beginning at an ash 3x  
on the bank of said Rabun's Creek then running N. 14 W. 11-40 to a red  
oak 3x then N. 85 W. 29. to a Chestnut 3x bounded by William M. Mahan's  
land then South on the old Indian boundary line 41. to a Stake 3x &  
bounded on said Robert Deane's land, then East 20. to the Creek & bounded  
on Jane Kelletts land, thence up the meander of said Creek to the  
beginning including the House & plantation where Venice Corbourn  
now lives with Ninetyfive acres of land be the Same more or less  
Together with all & Singular the rights members Hereditaments and  
appurtenances to the Said premises belonging or in anywise in-  
-ent or appurtenant to have & to hold all & Singular the premises  
before mentioned unto the Said Robert Deane his heirs & assigns  
forever & I do hereby bind myself my heirs, executor & administra-  
-tors to warrant & forever defend all & Singular the said premises  
unto the said Robert Deane his heirs & assigns against myself &  
my heirs & against every person whomsoever lawfully claiming
