 Barton the sixth day of February one thousand seven hundred and eighty six
 and conveyed by him to my father Francis Holley the third day of October
 one thousand seven hundred and ninety six situate lying and being
 in Greenville District aforesaid on branches of the North fork of Salu-
 da River and runs as follows viz, Beginning on a chestnut timber
 chain to a Hickory thence N 16. chains to a Hickory thence N. W. 6. 40 chains
 to a chestnut thence S. W. 9. 37 chains to the beginning containing one hun-
 dred acres more or less as aforesaid Together with all and singular
 the rights, emoluments, hereditaments and appurtenances to my share
 or part of the said premises, beloning or in any wise incident or
 appertaining to Have and to Hold all and singular my said share or part of the
