150. feet along a street that is 40 feet wide to a Stake near the Buncombe
Road thence North 74° West 200 feet to a Stake thence South 16° West
150. feet to a Stake on a corner of lot No. 40. sold to David Carr as
aforesaid thence South 74° East 200 feet to the Beginning, which
said lot the Buncombe Road runs through to have and to hold
all and singular the premises before mentioned unto the said
Moses Jones with the in consideration of ^{the} said Road passing there

hereby bind myself, my heirs Executors & Administrators to wear

Moses Jones his heirs & assigns against myself and my heirs and against

The 27 State of South Carolina This Indenture made the twenty fourth
day of December in the year of our Lord one thousand eight hundred and
Twenty five between Moses Jones of the one part and Col Benajah Dunham
of the other part both of the District of Greenville and State aforesaid
Witnesseth that whereas the said Benajah Dunham has this day joined
the said Moses Jones in a note of hand & is security for the payment
to Varday McBee of the sum of one hundred dollars with interest from
the date and has further agreed and hereby obligates him self and his
Heirs to furnish and advance unto the said Moses Jones and his heirs in
addition to the foregoing sum of one hundred dollars and interest as
aforesaid the further sum of two hundred dollars making in the whole
the sum of three hundred dollars which the said Benajah Dunham is
bound for & bound to pay to and for the said Moses, According this indenture.
Witnesseth that the said Moses for and in consideration of the said
