of the sum of one hundred Dollars to him in hand paid by the John  
Ross have mortgaged unto the said John Ross his heirs or assigns one  
One & one half three head of cattle four head of hogs corn and feed  
and one Loam an Bed and all of working tools belonging to the  
premises also the house hold furniture which said property the said Carter  
Burgess mortgaged unto the said John Ross in virtue of having had and  
Received of the said Ross the said sum of one hundred Dollars to him in  
the said Burgess having the Equity of Redemption (viz) paying and disch-  
arging the said sum of one hundred Dollars twelve months from the date
