Alexander of Greenville district and State aforesaid, for and in consideration of the natural love and affection I have and bear for and towards my brother John Sloan of Greenville district in the said State and for his better support maintenance ease and comfort in life and the sum one dollar to me in hand paid by the said John Sloan have given granted bargained sold released and conveyed and by these presents, do give Grant bargain sell ~~release~~ and convey to the said John Sloan, all that plantation tract or parcel of Land situate lying and being in the district of Greenville aforesaid on the waters of Bearr dam creek of Middle Tyger, being part of a tract originally granted to Major Parsons and conveyed to me by Thomas Edwards by deed bearing date the 15th day of January A.D. 1822, Beginning on a Red oak by a Green line running thence West seven Sticks, to the Charleston road and one out and seven Sticks, to the District road four out and seven Sticks, to a Stake on Thomas Edwards Junr. line thence N. 50. W. four out and seven Sticks, to a post oak, thence N. 17. E. seven out and eight Sticks, to a black Oak, thence N. 50 chains to a black Gum, thence E 7 ch 50 links to a black oak, thence S. 50. E. four out and two Sticks, to a black Oak, thence S. to the beginning containing Two hundred acres more or less together with all and singular the rights members, hereditaments, and appurtenances to the said premises belonging or in anywise, incident or appertaining. To have and to hold all and singular the said premises with the hereditaments and appurtenances to the same belonging unto the said John Sloan for and during his natural life and should his wife Malinda Sloan survive him for and during her natural life or widowhood, but should the said John Sloan survive his wife then the Estate hereby conveyed to me, and revert to me, and should the wife of the John survive him to continue so long as she shall live or during her widowhood and should she marry to revert to me, and the same unto and of right belong to me as fully as if this instrument had never been executed, with full power and authority to enter upon the Premises, have use occupy and enjoy them, and the same sell and dispose of without hindrance let or obstruction of any kind whatever by virtue of this instrument. And I do hereby bind myself and my heirs to warrant and defend the same to the said John Sloan and wife for the term above specified against me and my heirs only.
