bargain & sell & release unto the said Aquilla Bradley a certain Tract or parcel
of Land containing one Hundred and Fifty acres situate in the State and district
aforesaid upon the branches of Reedy River being part of Two Hundred and Fifty
one acres originally granted to Joseph Nation, the six day of February 1788
conveyed from S. Nations to Hugh W. Day and from him to William Rose and from
him to John Goodman & from him to John Harrison and from him to John Smith
and from him to John Wright and from him to said Hawkins beginning on a
red oak corner the original, thence N. 39. 31 to a black oak corner, thence
N. 30. E. to a pine a conditional corner thence South a conditional line to a post
oak and Hickory corner, a conditional line, thence East a conditional line to
a Stake on the original line, thence S. 58. E. ^{the original} to a Black Jack, thence to the
