 to Joseph Box, bearing date 1788 and conveyed Elliott Clardy as by reference of said Deed  
 will more fully appear, Beginning on a Post oak corner running thence N. 20. W. 40 chains  
 and 50 links to a Post oak corner thence S. 80. W. 43 chains 95 links to a stake corner, thence  
 S. 25. E. 45 chains 50 links crossing the River to a stake corner, thence to the beginning  
 corner as by reference to the Grant will more fully appear and including the Land within  
 the courses with all water and water courses Timber & profits and Emoluments or any part  
 thereof with all and singular the issues and profits hereditaments including or any wise  
 appertaining to the said Two Hundred acres. And further the said Elliott Clardy does covenant  
 with the said A. D. Bradley and does warrant and forever defend the above mentioned pre-  
 mises aforesaid from himself his heirs, Executors and every other person or persons lawfully
