


Gum on the bank of said creek on Hardin Roberts line thence south wardly on said line

 by these presents do grant, bargain, sell and Release, unto the said Tandy Walker all that
 plantation or tract of land containing Two hundred and twenty six acres be the same mo-
 = re or less situated lying and being in the district of Greenville and State aforesaid, on
 the waters of the South Fork of Saluda River; Beginning at a hickory on the Bank
 of the River and running s. 64. E. 27. to a pine thence s. 5. E. 10. 50. to a stake thence N. 82. E. 36. to
 a Stake thence N. 13. W. 43. to a Chestnut thence N. 75. W. 31. to a stake thence s. 51. W. to the
 Bank of the River and thence down with the meanders of the River to the begin-
 = ing Hickory Corner; Being the same tract that was originally granted to William
 D. Bradford by Grant bearing date the fourth day of December Anno Domini
 Eighteen hundred and fifteen and by him conveyed to me by deed dated the nineteenth
 day of November in the year of our Lord one thousand eight hundred and twenty five
