 by William Brasier senr of Edgefield District in the State aforesaid
 have granted, Bargained, sold and released, by these presents do grant
 bargain, sell and release unto the said William Brasier senr a certain
 tract of land as described and laid down in the grant and plat
 of the State to alstated West dated the first of December 1800 also one
 other tract of 300 acres adjoining the aforesaid tract as described
 in the said grant West to Edwards and from Edwards to my
 self all which tracts or parcels of land lying and situated in
 the District of Granville in the State aforesaid Commonly known by the
 name of the Parishes maintain together with all and singular
 the rights, numbers, hereditaments and appurtenances to the said pre-
 mises belonging or in any wise incident or appertaining to have
 and to hold all and singular the premises before mentioned
 unto the said William Brasier senr his Heirs and assigns for ever and
 I do hereby bind myself, my heirs Executors & Administrators to warrant
 and for ever to defend all & singular the said premises unto
 the said William Brasier senr his Heirs and assigns against my self and
 my heirs and all persons lawfully claiming or to claim the same or any
 part thereof by or through me. Witness my hand and seal the 10 day
 of March 1826 and in the year of the Independence of the United States
 signed sealed & delivered in the presence
