 aforesaid the receipt and payment whereof is hereby acknowledged have
 granted, bargained, sold, conveyed, transferred, released and assigned and by these
 presents do bargain, sell, convey, transfer, release and assign to the said -
 Jurimiah Cleveland all our claim, interest, Estate of what kind or nature
 some of in and to a certain tract of Land whereon our mother Mrs. Bath
 -aine Hawkins now lives as one of the heirs of the Eaton Hawkins deceased
 under his will, as well as all our interest and claim to any portion under
 the said will by the proceeds of the sale of the said land provided the same
 should be sold and we do hereby empower, authorize and direct the
 said Jurimiah Cleveland his heirs, Executors and administrators to ask claim
 - and sue for and receive of and from the Executors of the said will and
 all other persons the portion share or part of the said land or the proceeds -
 thereof to which as one of the heirs of the said Eaton Hawkins are or may
 be entitled on our said mother Mrs. Bathaine Hawkins death and the
 same when collected or received to have hold and enjoy to him and his heirs
 forever and also the amount which may be due to us under the will a
 -foresaid out of the proceeds of the sale of the said land if the same should
 be sold. And we do hereby bind ourselves, our heirs, Executors, Admini-
 -strators and assigns to warrant and forever defend the same to the said
 Jurimiah Cleveland and his heirs forever against us and our and each
 of our heirs, Executors, administrators and assigns and against every

 plantation, parcel, or tract of land situated in the District of Greenville
 and State aforesaid on the Grove Creek containing two hundred and thirty

 and running thence from an ash corner up the Spring branch on
 110
