unto the said William Robbs all that plantation or tract of land containing
one hundred and fifty Acres be the same more or less lying and being in the
district and state aforesaid on both sides of a branch running in to South
Tyger River. Beginning at a pine 3x N. 85. 40. to a Post oak 3x thence N. 89. 40.
to a red oak 3x thence N. 90. W. 28. 50 to a stake 3x thence N. 110. 37. to a Red oak 3x N. 70
E. 38. 50 to a red oak 3x thence south 32. 50 to a white oak on the Branch thence
thence up the meanders of the branch to a gum 3x thence south 20 E. 26 to the
beginning corner bounded on the East by Jepse Cannons land on the south
by Capt. John Watsons deceased land on the west by George Salmon's land on the
North by Jepse Rector land. All and singular the right title & interest of said
