

 Wills Henning all that Lot Tract or parcel of land situated lying and being,
 in the district of Greenville and State aforesaid on the waters of Brushy Creek
 and bounded as follows To wit, Beginning at a stake running North 30 chains
 to a red oak the fallen down corner thence west 50 Chains to a stake thence South
 30 Chains to a stake thence East 50. to the beginning Stake Bounded North by
 William Jacobs, bounded South by Miller Benson East by Roark West by
 Hall being part of a tract of land that was granted to Richard
 Chiles Containing one hundred and fifty acres more or less. Together with
 all and singular the rights, members, hereditaments and appurtenances to the
 said premises, belonging or in any wise Incident or appertaining To Have and to hold
