South Carolina <sup>3</sup> Know all men by these presents that I Ben Greenville District Benjamin West Junr. of Greenville District in consideration of two hundred dollars to me paid by Benjamin West Junr. of sd district I have granted bargained sold and released and by these presents do grant bargain sell and release unto the sd Benjamin West Junr. a plantation or tract of land lying and being in Greenville District on the head of Fox Creek of South Tyger River adjoining lands surveyed for Reuben Barrett on one side Beginning on a red Oak corner N. 75. E. 35. to a post oak then S. 20. E. to a conditional corner on the Branch thence down said Branch to a conditional corner on a ash thence a strait line to one more conditional corner to a post oak on the other line thence N. 20. W. to the beginning corner on the red oak the same being apart of a tract of land granted to Shadrack, Henry and said Henry sold and conveyed to Labor Loftis and by said Loftis sold and conveyed to Archer Holcombe and by said Holcombe sold and conveyed unto John Leece and by sd Leece sold and conveyed unto the above Benjamin West Junr and by the above Benjamin West Junr sold and conveyed unto the above Benjamin West Jr. containing one hundred acres be the same more or less including the improvement wherein sd B. West Junr. now lies Together with all and singular the said premises Rights, members, Hereditaments and appertinences there belonging or in any wise appertaining to have and to hold all and singular the sd premises before mentioned unto the said Benjamin West Junr his heirs and assigns for ever and I do hereby bind myself my heirs Executors and administrators to warrant and for ever defend all and singular the said premises unto the said Benjamin West Jr. his heirs and assigns against myself my heirs and assigns all and every other person whosoever lawfully claiming or to claim the same or any part thereof In witness whereof I the said Benjamin West Junr. have hereunto set my hand and affixed
