 to the said Waddy Thompson Jr. Together with all and singular the rights me-
 -mbers hereditaments and appurtenances therunto belonging or in any wise
 incident or appertaining and I hereby bind myself my heirs Executors
 Administrators or assigns the same to warrant and defend to the
 said Waddy Thompson his heirs or assigns forever against the claim
 of all persons whomsoever claiming or to claim the same In
