 District So. Carolina Have Granted, bargained, sold, and released and
 by these presents do grant, bargain, sell, and release, unto the said Doctor
 Robinson M. Earle all that tract or parcel of land situated in
 Greenville District and State of South Carolina on Rudy River
 Containing four hundred and ten acres 410, bee the same more
 or less bounded by a line from the Red Oak corner on the old road
 at a place called the Sandy Mallard thence S. 61. W to you Alins line
 thence S 24 W to said Minn white Oak corner which is down thence to
 a gum corner on the bank of the River at the foot of the bridge, the
 old bridge is went thence down the River to the mouth of the
 Creek Called the flat bank branch thence up the said creek
 or Stake line to a hickory in the old road called Halletts road thence
 up the said road with its meanders to the begining. Together with all
 and singular the rights members, hereditaments, and appurtenances to
 the said premises beginning, or in any wise incident or appertaining
 to Have and to Hold, all and singular the premises before mentioned
 unto the said Doctor Robinson M. Earle his heirs and assigns for ever and
 we do hereby bind our selves, heirs Executors and Administrators, to warrant and forever
 defend all and singular the said premises unto the said Doctor Robinson M. Earle
 his heirs and assigns against our selves and against every person whomso
 ever, lawfully claiming, or to Claim the same, or any part thereof
 Witness our hands and seals this eighteenth day of March in the year
 of our Lord one thousand Eight hundred and twenty nine
 and in the fifty third year of the independence of the United States
