 a pine thence N. 29. W. 8. 50 to a red oak thence S. 65. W. 35. 50 to a black Jack

 and singular the priviledges and appurtenances therunto belonging  
 or in any wise appertaining unto the said Joshua Ingram his heirs and afi-  
 gns for ever and to the only proper use and behoof of him the said Joshu-
