


 nted to William Mother died by his Excellency William Mother on
 the 3rd day of Apr 1786. that part of sd tract beginning at a
 Chimney 3x on Rogers Spring branch thence up the meanders of
 sd branch to a Hickory 3x thence N. 70. E. 9 to a red oak 3x thence
